1. Biehmiapa

Kha hlâta Marapa ta a hmia a pahno beih leipa internet, computer nata Mobile (smart) phone zy kha, atanoh cha a hmâ chaipa azaona chhaichhi a vaw châ haw. Khitawpa liata cha eima châna zydua apahnokhei khaipa pi ta, eima likah liata bienyupa/bierupa y thai khao vei. Cha hawnhachata, Information Technology (IT) chhâ liata cha khizaw pi tlai he "khizaw khitawpa" (global village) hawhta a vaw châ. Internet hmâpa ta, lâ hlâpi liata a ypa sanawrinôzy, viasa rihchâhpazy nata azaokhi khoHPa chyhsazy nata Social media hmâpa ta azaothei khaipa a châ haw. Chyhsazy anaota ta dôvei thaipa châ khao vei.

3. Social Media hmâpa phahnaina

3-1 Thâth pahnona châta (Information)

Internet hmâpa ta Online ta hmo zuapazy pahnosana (hmo mâ nao viapa), hmo thiehpâ ama papuapazy, khihnarâh nata khizaw liata hmo a tlô haipazy pahnosana, Sawhkha, NGOs nata Awnanopazy ta raihria awpa ta hmâh la haipa nata rai pahypa pahnosana, Meeting pahruana (awna), achuna kyh, scholarship kyh ...hpz. zawpi lâta pahnosapazy.

3-2 Achu haipa siku hawtizy

3-5 Hro palysana

Social media tawhta video, bie eima chho khohpa chyhsa nata achho theina, hmia hmô theina, cartoon, saisopa nanopazy, chyhsa tluatlâpazy thatihzy chhao pahno theipa a châ.

4. Social Media hmâ thai leina vâta rao theina

Social media taotuhpazy ta chyhsa to phahnai nawpa ta tao taraw ei ta, ahmâtuhpazy hmâ thai leina vâta he hawhta chyhsa hrona a parao thei. Chavâta asohsi kawpa ta hmâ awpa âbyuh.

4-1 Chanô-chapaw moleina lâthlôh a châ:

Social media he chyhsa thokha ta sôh hmôna châta satlia-laihsa thluahruapa nothlapazy, chanô-chapaw moleina lâta reipasaona video nata nothlapazy, chanô/chapaw apheinazy hawhpa taona su châta hmâ theipa a châ. Thokha chhochhi cha chanô-chapaw nothlâ pathaih leipa moh leipa ta a y thei khao leipa (porn-addict) ama hluh kaw. He hawhta video ama moh nga thlâhpa vâta chanô hawtizy chô liatazy, maniah lapinô nata vahpa chô liata zy molei khohna ama hnei tyh. Thokha chhochhi cha social media tawhta lapinô nata vahpa ama tlua. Ama tyh hra. Chahrâsala, hmiachhy ta a vâ-iapa ama châ leipa vâta ama vaw hnei nahta ama thâtih siapa a vaw pahno ei ta, âchhahpa hluhpi ama y.

Thokha cha moh khoh tlôh ei, media ama hmâ thai leipa vâta a maohphyuhpazy hluhpi ama y. Chavâta kô tloh leipa nata hawtizy cha nô nata paw pahno leipa ta social media ama hmâ awpa pha vei.

4-2 Chyhsa dôveina châta hmâna

Thokha cha social media he chyhsa dôvei ta, âmo a thôhna châta ama hmâ. Cha hawhpazy ama moh dopa nata ama nohthlâ hmeiseihpa hmâ leipa ta, chyhsa hropa moh nata nohthlapa hmâpa ta account ama pahy. Online tawhta dôveipa ta taka paphaosana, bank liata taka ano leipa lâta pasiesana, â thôhna (interest) hluhpi pie awpa hawhta bietaihpâ ta taka adôveipazy reitiahpa châ khao vei.

4-3 Thâchhie reina, ahryuna, hmiahaona châta hmâna

Social media liata cha chyhsa to ama riah a pha kaw. Ama chipa y vei. Chavâta chyhsa pahryusa awpa ta thâchhie reina, ahryuna, chyhusana nata hmiahaopa ta taona a hluh kaw. Atahma hlâ adyuhna daihti (revolution) liata chhochhi cha, eima phu/py tha patlô khohpa vâta phu/py hropa reipachhie, ama taozie ado leipa phuah, haihipa bie chyhsa to lâta châ paphao th. Chavâta miah ama pamoleisa kaw.

4-4 Daihti pahryuh thlâhthlina:

Chyhsa thaina hmâpa ta mobile application heta chyhsa lathli châta lôheih a papua theipa **dopamin** ama tahpa chemical ama hmâh. Cha chata *chyhsa syhdie ta, pahâ a patheisa*. Social media ei kha eima hmâh haw khiah, hmâ chanei ngâthlâh awpa khopa a pahneisa. Daihti ruapa hneina maih ta hmâ parie khohna, hmâ leipa ta y molo thei leina miah a pahneisa. Chavâta eima pahno hmâ leipa ta

daihti vâro tlai a vaw la hmâ ha tyh. Thokha chhochhi raihria khao leipa ta social media liata daihti a pahryuhpa thlâthlipazy hluhpi ama y.

Facebook liata eima chârohpa nata status update zy mo hropazy ta 'like' ama vaw pie hôlô khihta cha aly paru kaw tyh. Mo chazie "like" ama vaw pie haw, keimo châ ropa moh chazie ama moh haw, tahpa vâta facebook leipa ta y molo thei leina taihta pahâh miah a patheisa (*dopamine*).

Thokha cha ama mô chy ta, lahuah kiahpâh liata mobile soh ei ta, ama vaw hrana maihta, phone ama chathlia tyhpa vâta mokuh pasaihsa ta, a chhâna liata cha hnatlana chhao a parao tyh.

4-5 Chhôngkha Akaona paraona:

Rei chiehpâ hawhta social media he hmâ thai khihta cha chhôngkha paduana liata chhao thata a pahnai. Eima hmâ thai vei khih deikua cha chhôngkha raona chhao a châ thei hra. Atanoh Mara ochhôn to ta mobile eima hnei khai. Maluh pakha-phone sâkha hawhta hneipa a châ haw. Hawtipa, thyutliapa nata machâpa zydua chhao mobile eima hria khai haw. Chhôngkha thlahchhâna nata akaona hnei awpa hlâta, mobile nata tiao eima kao via haw. Paw ta video moh, nô ta game, eima satlia/laihsazy ta hla, hawti nawhta cartoon mohpa ta eima rai tly tlâ vei. He hawhta daihti vâro tlai eima vaw sie khihta cha, Mara chhôngkha cha mobile/social media ta a parao khai ha aw. Hawtazy he cartoon ama mopa chhao ta, a rakhapa deita pamosa awpa a pha. Hawti padona châta mobile eima pie thlâh ha

khiahta cha, hawti mohôhna liata âmo tiao eima parao ha haw.

4.6 Taka sôh pachhâna a châ;

Mobile phone a ypa vâta social media hmâ thaipa châ hlei vei. Internet pazao leipa khiah, mobile cha mydi miah pathyutuhpa awkhypa, zâ zohna daihti liata khaihna miah piepa dawhmei hawhta a châ. Mobile tawhta social media hmâ thei nawpa ta Internet pazao awpa a châ. Lialipi liata cha TPA ta ahneipa Starlink liata dawhkha ta Ks. 5,000/- piepa a châ. Nohkha chhôn eima hlaofâh khiahta cha Ks. 10,000/- hmô theipa liata Internet (wifi) liata cha dawhkha ta Ks. 5,000/- hmâ awpa a châ. India Airtel & Jio sim eima chalei khiah, thlakha ta Rs. 280 (Ks. 20000) a châ. Cha chhao cha internet line patu thei tu vei. Rei khoHPa cha hryuhna sai a châ tahpa hih. Social media he yzie hneipa nata peimawh tu leina liata hmâ khiahta cha, taka sôh miah pahryuhtuhpa deita a châ.

5. Social Media nata Satlia-laihsa dawpazy (kô 13-19pa teenagers)

Satlia/laihsa dawpa (kô 13-19 likawh teenagers)zy he kyh to achu khohna, taopachhi khoHPa ama hneina daihti a châ. Pachutuhpa y leipa chhao ta, âmosasyh tao ta a thaipa ama châ haw. Social media chhao yzie hnei kawpa ta ama hmâh khiah ama thôhkhei hra aw; ama hmâh thai vei khiah, ama raokhei theipa vâta social media kyh no pavâhsa awpa apeimawh kaw.

5-1 Dopamine:

Social media papihtupazy heta "Attention Engineers" (pathipalôh tlokhuh pie ta pachâsana athaipazy) hruapa ta social media ta ama vaw pataosapa a châ. Pamosana ta, facebook tlyma, media liata nothlapa sâkha ama paso nahta chyhsa hropa ta "like, love" hawhpa piepa ta ama vaw comment tita, chyhsa lathlie heta ta "dopamine" ama tahpa chemical sâkha a vaw papua. **Dopamine** tahpa cha chyhsa lathli châta lôheih hawhta *chyhsa syhdie ta, pahâ a patheisa thei ta cha chata* palôhtlâhna, thaphana, alyna a pahneisa. Cha cha buakha deita alyna châ ta, lathli tawhta dopamine hluhpi a vaw papua khiakta cha "pahâtheina," "y molo thei leina taihta tao khoh, hria khohna" palôh a pahneisa. Châhnamei pazypa nata sahmâ dopa ta âtaih thei khao leipa hawhta, social media hmâ leipa ta y molo thei leina hro a papua.

5-2 Dopamine heta thyutliapazy social media hmâna liata a pachie khohpa a pahneisa. The Centre of Collegiate Mental Health" ta research a taona ta social media heta chyhsapa hro liata "pachâ chhiena" (anxiety) nata "palôh ngiaroh hnabeidyna" (depression) a pahneisa a tah. Satlia/laihsa kô 18-29 likawhpazy heta noh kha ta achyh chaipa dawh 2 he social media liata ama daihti ama hmâh tahpa a châ. Dopamine vâta he hlâta hluh via ama hmâ nahta, amô thei leina, moku saihna a pahneisapa vâta hnatlana taih a parao thei haw.

6. Cybercrime (Social Media hmâ thai leipa vâta hriena)

Social media he hmâ thai khiantha cha, chyhsa zydua châta yzie hnei kawpa nata a mâ hnei kawpa a châ. Anodeikua cha eima hmâ thai leipa khiantha cha Sawhkha hmiakô liata dâh paraopa châ aw pi ta, hriena miah a tlôkheipa a châ. Social media hmâ do leina thokha eima palâsa aw.

Atahmahlâ IT (Information Technology) chhâ liata computer nata internet hmâ do leina lai chaipa cha cybercrime ama tah. Chyhsa hropa maoh paphyusa/maoh paphaosa awpa tlyma, mopakha khotalaina parao awpa tlyma, noh pazao awpa ta tlyma, mobile, SMS, phone call, computer nata internet hmâpa ta dôveina a châ. Chavâta asohsi kawpa ta hmâ awpa a châ. Cybercrime liata hezy âhlao aw.

6-1 Hacking:

Computer hmâpa ta maniah computer network chhoh lâ vâ ngiapa ta, ama data (châ peimawhpa) parupa tlyma, paraopa tlyma he hacking ama tah. Internet hmâpa ta maniah credit card (tâkâ) parupa nata computer hmâpa ta bank liata tâkâ azipa pahno leipa ta bank hro lâta paphaosa ta paruna chhao he, hacking ngiathia a châ.

6-2 Cyble stalking:

Internet ta tlyma, email ta tlyma, electronics hmâpa ta biechhona kheirohpa tlyma hmâpa ta phone ta tlyma, châ ropa tlyma ta mo hropa pabuana, pachhiparyna, thlah pazona hawhta taona a châ.

6-3 Scam:

Mo thokha cha sôh tluana, hmo chalei ta, zuana kyh liata chyhsazy so kawpa nata thai kawpa ta ama dôvei tyh. Alaichadai hmeiseih awpa y tlôh vâ; tâkâ hluhpi hmô theina kao a ypa hawhta beiseihna pie ei ta, cha chyhsazy hnohta cha zie, khazie miah vaw paphao tua la, tahpa ta dôveina a châ. He hawhta ta dôveipa khoheih liata â aopazy cha ama hneipa sôh, o nata lyu taihta ama pahlei ha tyh.

7. Social Media nata Awnanopa

Mara Awnanopa heta Social media eima hmâh thai nawpa ta, Khazohpa bie tawhta achyhta eima chu aw.

7.1 Rei chiehpaw hawhta, Social media cha khaw chhaichhi (device) tlâ châ ta, keimo ahmâtuhpazy pi heta evangelist tlyma, sahrâhpa tlyma eima châ thei thlâh haw. Social media he adyuh awpa nata arâsai awpa châ leipa ta, eima pha nawpa ta hmâ thai awpa âbyuh. Eima chakhaona nata châna hawh tlaita apielyu thai awpa a pha.

7.2 Awnanopa phapazy chata Media he zawpi hnohta khodâh hawhta biereina khaw hawhta hmâ awpa châ vei. Thokha cha social media liata ama moh tlyma, ama nohthlâpa hmeiseihpa palâsa ngâh vei ei. Haidipa khodâh hawhta ama rei thei nawpa ta sasyh châna hmeiseihpa cha ama nyu haw.

7.3 Social media heta Awnanopa he sei ta miah a tao awpa châ vei. Rm 6:16 liata "Ahy liata rai ama bie zyh awpa ta sei ta namâ ngiah khihtala thina taihta moleina sei tlyma, siana taihta rei a ngiahpa sei tlyma, a bie nama zyhpaw sei cha nama châ tahpa pahno veih eichi mâ?" a tah. Social media he keimo miah a chakaotuhpa, eima

sei, eima yru miah papaituhpa nata eima tualituaipa a châ awpa a châ. Keimo rei ta a y thei awpa eima châpa tlai ta, social media rei sai ta y thlâh ha khihta la, ado khao aw vei, tahna a châ. Social media heta daihti leipa liata miah pahneisatuhpa, viasa miah a pakyhsa leituha, moku miah pasaihsatuhpa, rai miah pahriasa leituha, apakhyna miah pahawhsatuhpa, nata tâkâ miah pahryuhsatuhpa a châ awpa rai rai châ vei.

7.4 Social media heta eima châna (identity) palâsa tyh. Atahma hla khizaw liana heta pôhpa ta hmia nah hmiachhyha ta bie reih khao mah pi. Social media hmâpa lâ hlapi liata a ypazy chhao kha, lâ hniapa liata a ypa hawhta eima pakyh thei haw. Chavâta eima châna hmeiseihpa cha social media liata palâsapa ta a y haw. Eima ngiapâna, hrozie, bierei-kâhthlâ, pathipalôh phaozie, pahâhna nata pahâh leipa kao chhao social media tawhta pahno thaipa a châ haw. Phu/py laipa nata company laipazy ta hriatuhpa ama la tita, eima Curriculum Vitae (CV) deita moh khao vei ei. Social Media liata *facebook*, *whatsApp*, *twitter* ...hpz. account hnei/hnei lei tiao ama hiahri tyh. Cha Account tawhta eima châna zydua pahno khai theipa châ ta, dôveipa nata haihipa ta rai hia thaipa châ khao vei. Facebook liata eima chârona dâh, chyhsa hropa chôropa chô liata comment piena dâh zydua he "ahyma ei châ" tahpa pahno theipa a châ. Chavâta social media he yzie thei kawpa nata mâ hnei kawpa ta hmâ thai awpa âbyuh.

7.5 Eima hrozie nata châna nata âhmiepa byh (box or group) liata y awpa a pha. Pastor pakha châ chi ta, satlai-laihsazy saisona group liata y awpa pha vei. Politics group liata evangelist cha a y awpa châ hra vei.

Pahno thai nawpa ta eima rân politics adyuhna kyh, ahy tlyma a vaw ro nga no ta, keimo khôtho lâ tawhta eima chiabuhrân nga awpa pha vei. Biedopa nata do leipa pahnopasia tlôh leipa ta châ ta tlyma, comment nga awpa chhao pha vei.

Chi nata pho a pasâhsapa palôhru phao (patriotism) pachâna tawhta eima sai khiatacha Marapa nata Marapa nôvah ahneina tao awpa chhao he khokhei via awpa alyuna a y tyh hra. Awnanopa hro liata saw pachhâsana hro (taona) he issue miakha hawta nâ pyh thei ma? India sawkhâ cha maluh ama hlutupa vâta family planning ta sawkhâ ta dâh a siekheipa a châ thei ngyu aw. China sawkhâ chhao hlâviano ta cha chhôkhka miakha ta saw pakha (1) dei hnei awpa ta dâh a tao, ei pahno chheilei khiatacha, atlia liata cha saw pano (2) hnei thei awpa ta dâh a paryh pakhuapa ta ei pahno. Mâ tahpa a vaw yna chhâpa cha chapaw ta chanô lapinô ta a hneipa he anaosia kawpa ta mae ⁴⁹(divorce) chakhy theilei nawpa ta nata chanô chhao ta avahpa tawhta anaokawpa ta akusai theilei nawpa châta a châ hra.⁵⁰ Pupa nata piapa, tusawzy azaokhina phapa a y thei nawpa cha chhao ta pachâpa a châ hra.⁵¹ Mâ kyh eima rei hlâta, eima phoryhpa ta “Chysa maniah pathluapa” “culturally or racially alienated person or excluded people” tahpa hawraw he pachâ tua awpa abyuhpa ta eipa hno. He hawrawh he khizaw hmasiena kholâ chhâ (post modern age) ta a siesai laih ngâpa châta, faminist theology, liberation theology, tribal theology zy nata azaona a hnei. 2024- MEC Assembly Executive Meeting (Aru), minute bu

AD 1800 chhaichhôn liata India rân Kerela State Tranvancore ryureina daihti (The kingdom of tranvancore) a châpa ta reih eita, pho nawh viapa (Lower caste)zy hnohta ama taopa dâh cha chanô hnô mâ (the breast tax) he a châ.⁵³ He hnô mâ chhiekheina he pho nawh viapa a châpa, **Dalit** nata **Shudra** chipho tawhta chanôzy hnohta ama hnô mâ ama kheipa a châ. Ahnô alai viapa ta alai viapa hawhta ahlu via amâ cheita, a hnô achy viapa ta a chy viana hawhta ma a chei hra. Mâ phahnaina a ypa a châ khiatala, pho mopa ta, pathlaupa ta ma mâ he eima haw tlai aw? Mâ pahlei awpa chhao peina y hlei aw ma? Chysapa nôvah châna liata a peimawh chaipa cha mâ he châ hlei vei, adyhna, apôhkhana, kyhpachâ rairina hpz he tiao a châ. He hawhpa he mâ ta a tao eima tah thei aw ma?

Chysapa châna nata phorypa he pachhaih thai aru kaw. Chysapa y na maih liata phoryhpa a y lymâ tyh. Phoryhpa nata chysapa he miakha nata miakha a pazao rairi (inter-related) a châ. Pachâ awpa deikua cha, eima phoryhpa eima hneipa he ta eima chhâ nata âhmie mâ, eima khitiâh hro phao maniah pahrisapa a châ mâ, eima zyhna (awnanopa eima châna nata a pakaoh thai mâ) tahpazy he a châ. Phoryhpa chhiepa cha siesai ta, phoryhpa phapa deikua pa-i lai awpa nata palaiseisa awpa â byuh. Eima phoryhpa a châ lyliata, hmâ parie awpa châ hlei vei. Phoryhpa maih ta hmâleipa aw pita, a phapa phoryhpa cha paza lai aw pita achhiepa (chhâ nata a hmieleipa, awnanopa hro (Biehrâi nata amieh leipa) zy cha eima siesai lai awpa a châ. Marapa he phoryhpa eima hneiroh kaw. He phoryhpa eima hneipazy he ta achâh ta cha khitiâh hro phana lâta maniah tao lai hrana a y holo. Thokha eima phoryhpazy deikua cha awnanopa rie maniah patheisa kaw tyh hra. "Asei tua khi, aw via thie khi," "Chanô dô, Azyh dô" hawhpa Biesozy he hmâ awpa ta atahmâ chhâ ta hmâ ng awpa bieso châ khao vei.

Phorypa (Culture) phapa heta khiipi/ khihlâh hro phapa tao ta, culture phaleipa heta chipho nozaona a tao hra. Van Kung rohpa Dawchhau Theology ta a reihpa cha “Zakha cha eima o kiapâh liata chana ao ei thei, cha chanô chana ao cha khapa vata e tahpa ta ei nô ei hiahri. Ecosystem ama tahpa cha Khazohpa taopa Idâh sadô liata chyhsapa nata hmohrohneipa zydua ta a phahnai veichâhpa ta huhieh kawpa ta hrona a châ. Cha liana cha, husona ahneipa nata hnei leipa chhao, thokô-râhkôzy chhao, leilô/ti chhôn liata a pahrâpa chhao, â zaw thaipa pavaw-pazu zydua chhao ta hmaokha ta hro ahly thaina chheipâh phapa he a châ.

Cha hawhta chheipâh phapa a vaw châ thain'awpa ta Khazohpa ta vâsua-nohsa, chakua nah lalôhpa he a vaw taopa a châ. Cha cha ecosystem chhôn liata a pahrâpa hmohrohneipa zydua châta a daihti ta liata a phahnai veichâhna (Symbiotic) ama hnei theina awpa a châ. A chhâpa cha chyhsapa nata hmohrohneipazy hrona, husona nata hnatlâ laiseihna zydua he âzao khai hawpa vâta a châ. Cha tlai cha pahrâ kho h â chhih kawpa chheipâh (Ecosystem) cha a châ.

He pahrâ kho â chhihpa chheipâh pachâsa awpa kyh he ngiapâtuha ahyrai ta taovyuh/hriavyuh eima hnei chyupa hawhta ei pahno. Khizawpi pôpalôhpa UN chhao ta he kyh vâta chhôn daihti, taka hluhpi hryuhpa a hria pazi lylia haipa chhao a châ. Keimo Mara rân nata Chin rân chhao he eima

vaw pahno hmâ leipa daihti liata he ecosystem he eima vaw parao khai daihmâ haw.

He hawhta a rao khai daihmâ hawpa ecosystem cha padua pathi heih awpa ta nata khâsia lylia awpa ta MEC Assembly ta hmalana a vaw taopa he aly tlâh a châ hmeiseihpa a châ. He kyh he hlahpa pachhana thâtihpâ bie chhopa hawhta tiama kawpa ta rei awpa ta ei pahno. He seminar a vaw hlao theipa eima zydua ta a taotiana awpa dâh nata rei papua lai h awpa vision phapa a vaw puakhei thlyu aw, tahpa hnabeiseihna chô ta he paper he ei vaw pachuahpanohpa a châ.

2. Biechhôn



He hawhta a daihti leipa liata vâsua ru kawpazy suah, thlihpi ru kawpazy pathli, ti that alai, tahpa ta chyhsa thina, o nah lyu raokeina, chichei raokeina hpz. vâta rairuna thata eima tyh ngâpa he a châ, a tah.

He hawhta khihchâh âdo khaona vâta a vaw y thai awpa rairuna tawh eima khôkhâh thei vian'awpa ta, keimo tlai ta eima paryh/pachâ chhielie awpa a châ. Sawkhâ ta khatino rai ta maniah taopa thei aw vei. Marapa he odyh 100% liata 90% rachhhôn he luthlyupa ta nie â tluapa eima

châ. A yzie cha Marahpa cha lyurâh thokôpa tawhta nie â hmôpa eima châ, tagna châ. Chavâta, chichei dâh, lyutao dâh, lyurâh thokô khâsia-mohohna dâh, lyurâh sa-nga pabohsa nie thaina dâh, eima chavah tihnawh mohoh thaina dâh, eima hnei tlakaihpa leilô nata a chhôn liata a ypa resources zydua he saw-samoh-sahlah-sachhih (chhâ hluhpi taih) ta hmâ thai, nie thaina awpa kyh zy liata Marahpa zawpi ta novâhna hnei thai khai awpa a peimah kawpa a châ.

He kyh liata eima pachâ pazih awpa nata hria pazi awpa hmozy cha ary lâ hawhta a rakhapa ta ei vaw palâsa aw.

Khizawpi maluh mo pa(10) liata pa(1) he thotlâh rân tawhta a puapa ti, thlih, nie, pahrâna awpa o zy ta a hrohpa ama châ. Ti nah tlâh â hnai-âsâh, chakua lalôh â nanopa hawhta a chhôn liata a pahrâpa hmohrohneipazy (Biodiversities) chhao ta a ypa ecosystem a châ. Khizaw liata chavah ti phapa a vaw puana he thotlâh rân tawhta a châ. Khizawpi maluh 8000 millions hry ta 3000 millions hlei he thotlâh rân tawhta ti ahmâhpa ama châ.

He thotlâh rân ecosystem he a rao chatlie thai chaipa a châ, ama tah. A eih via pachai ta a rân liata a pahrâpa chyhsazy ta lyu tao (Shifting cultivation), thothihpa parao, vâsua rupa parao, alei chona nata tilaina hawhpa zy a châ.

Ecosystem he chyhsapa vâta kô chareih ahluk nah achyh arao lymâ haipa a châ. Chyhsa maluh pôh via a râh chhôn liata a pahrâpa hmohrohneipa (Sa, nga, pavaw-pazy) zy chhâ via, rao via tahpa a châ. Chheipâh phapa rao thaina chhâpazy chi(3) zy cha: (1)Population Growth, (2) Over consumption, nata (3)Technology Growth zy châta, a pachhohna lâ ta "POT (Beih)" ama tah.

Aleichô riahdyuhna pipa ei(2)na daihti liata Myanmar râh thothihpa eimahneina he 60% a châ, ama tah. Tahmâ daihti liata cha thothihpa eima hneipa he 45% rachhôn dei a châ haw. Thothihpa a vaw chhâ laiha chhâpazy: (1) Chyhsa maluh pôh lymâpa hawhta khihthieh râththiehpapakawhna, (2) Nie nah baw châ ta chicheina Iyu/sadô su vaw pakawh laiha, (3) O sana châ ta thokô thluna (Dyh o, sawkha o sana), beihchhona ti awpa tho hmâna (A chyh chai ta Chhônkha ta mawtawka ei kha phao sai), (4) Taka hmôna awpa Chainsaw ta tho-âhna, (5) Mawtaw lâpi chhiana nata a hropa peimawpazy vâta a châ.
